Builder/Remodeler First Time User Rebate: The AdvanTech® flooring and sheathing and ZIP System® sheathing First Time User Rebate is only available to professional building companies that have not purchased and used Qualifying Products prior to January 1, 2016 ("Qualifying Building Company"). Rebates cannot be issued to individuals or homeowners. Qualifying Building Company can receive a \$3/panel rebate on up to 300 panels based on the following products ("Qualifying Products") and quantity limits:

- >> Up to 150 panels of any AdvanTech flooring and/or sheathing product not purchased prior to January 1, 2016
- >> Up to 150 panels of any ZIP System sheathing product not purchased prior to January 1, 2016

Retail Salesperson Incentive: All retail salespeople are eligible for the incentive unless your employer prohibits participation. Retail salespeople can receive \$0.50 per panel on up to 300 panels of Qualifying Products sold to a Qualifying Building Company. There is no limit on the number of Qualifying Building Companies a salesperson can submit.

Payment Details: Payments to the Qualifying Building Company will be issued within approximately 60 days after receipt of completed registration form and valid invoices. Payments to the retail salesperson will be issued within approximately 60 days of receipt of completed registration form.

Participation Details: Qualifying Building Company must buy Qualifying Products for the first time between January 1, 2016 and December 31, 2016. Submit the completed registration form above along with invoice(s) showing Qualifying Products purchased. Please choose from the following submittal options:

After submitting this initial registration form, continue to submit invoices of Qualifying Products purchased through December 31, 2016 up to the maximum quantity limit allowed on rebate. All invoices must clearly indicate Qualifying Building Company name, name of Qualifying Product purchased, quantity purchased and price paid. All registration forms must be postmarked or faxed within 30 days of the purchase date listed on the invoice and received within 45 days of purchased date listed on the invoice to be eligible for rebate. Purchases made by homeowners on behalf of their builder cannot be accepted. Purchase must be made by professional building company to be eligible for rebate payment.

Additional Rules and Regulations: Rebate is available to professional building/remodeling companies only ("Qualifying Building Company"). Rebate is not available outside the United States. Eligibility for the rebate may be independently verified at Huber's sole discretion. Rebate cannot be combined with any other promotion. The maximum rebate per Qualifying Building Company is \$900. Retail salesperson maximum is \$150 per Qualifying Building Company. Valid invoices must be submitted by deadline to qualify for rebate. Huber is not responsible for lost, misdirected, mutilated or postage due mail. Rebate checks will be issued to the building company rather than to the employee-purchaser.
